

**314. Vacancy for the position of Rector of the Montanuniversität Leoben for the term of office  
1.10.2023 – 30.09.2027**

The Montanuniversität Leoben wishes to fill the position of

**Rector (m/f)**

with effect from 1 October 2023, in accordance with the Federal Act on the Organisation of Universities and their Studies (Universities Act 2002, BGBl I No. 120/2002, valid version). The term of office is 4 years. The position of Rector shall be exercised within the framework of a temporary service contract with the Montanuniversität Leoben.

The Montanuniversität Leoben is a technical university with a special orientation and close relationships with industry.

The duties of the Rector are defined primarily in § 23 Clause 1 Universities Act 2002. Under § 23 Clause 2 Universities Act 2002, only a person with international experience, knowledge of the Austrian and European university system and the ability to carry out the organisational and economic management of a university may be elected as Rector. Experience in management and in carrying out research is expected. A connection with technology and the natural sciences as a result of previous professional activity is desirable.

Applications for the position described should contain detailed documentation on the expected qualifications. Applicants are requested to present in writing their ideas about the principles of their administration, in particular with regard to fulfilling their statutory tasks and the further development of the Montanuniversität Leoben. Furthermore, it is expected of applicants that they are willing to present their ideas on management and the further development of the Montanuniversität Leoben at national and international level at a hearing, to which all members of the university shall have access.

The Montanuniversität Leoben endeavours to increase the proportion of women, especially in management positions, and therefore expressly invites qualified women to apply. Where qualifications are equivalent, women shall be given priority.
